### STAFF AND COMMITTEE REPORTS:

- 1. Project Updates
  - a. Sales Tax Fiscal YTD is up 13.9%. 2020 Budget is 12% over projection.
  - b. 707 Halsell Purchase waiting on Linebarger to reschedule the sale
  - c. J&M Materials -There is a new contract on property.
  - d. Ace Hardware BEDC has not had an update from them.
  - e. COVID-19 Update Cases are declining in Wise County.
  - f. Project Flex Working to get appropriate paperwork to finish EDPA.
  - g. Wise Recovers Economic Relief Fund Businesses that applied should have received funding or a letter stating why they are ineligible from the County.

- j. Retail Strategies We are going to be using numbers for 2019 and Executive Director and Assistant will be doing Retail Academy training online instead of traveling to Alabama.
- k. Project Augustus Gloop BEDC did not complete RFP due to blasts from the rock crusher violating the strict project requirements involving no vibration and movement around the facility.
- I. Project Defense They have decided not to purchase 2004 Hwy 101 due to the high renovation costs. They could possibly need a 50,000 square foot building in the future. Endeavor has been discussed. They are currently searching for a small office space in town to get a permanent Bridgeport address to fit the contract requirements of the State Department.
- m. Marketing Internship Lauren Stowers will be starting a new position, working on marketing, social media, and website development. She will be available to help the Chamber and Main Street as well if needed.
- n. Endeavor Adventure Park Parks and Recreation Department is applying for grants that can be used for road maintenance at Endeavor. This would primarily be on the recreation side of the park, but if there is enough money left, he would like to start clearing a path to the proposed entrance on Lake Road that was brought before us a few years ago.
