 - TIRZ #1 Board Recommendations Corey Ingram, David Lawson, Mark Tate have been submitted as board member recommendations.
 - Board Information Draft of Action Plan is in Board Books to review.
 - Sales Tax Leah Clark reported that the City's net payment was \$191,620, 7% over last year. Fiscal YTD is \$1.65 M, up 23% over last year. BEDC's payment was \$63,875.
 - Buildings/Grounds Caps should be installed on the wall soon to complete the Endeavor wall repair project.
 - Dry Creek Retail Development/ESP Commercial Leah Clark reported that there were no updates on the offer to ESP Commercial.

- Project Coffee Bean Leah Clark reported that the loan was paid off by an investor.
- Project Spire 2.0 Business is current on loan payments and performance agreement. They would like to give the Board a tour of the bottling facility.
- Main Street Leah Clark reported 47 Home and Garden will be opening May 14th. The Cookie Jar is closing at 905 Halsell. Leah Clark has reached out to Mark Rogers with Marker Cellars about going into that space. Stevens Street Grill recently sold, but there are plans to reopen.
